Any person operating or conducting business within the City of Westfir shall obtain a license and pay an annual license fee in the following amounts:

- (A) Out-of-town businesses, doing business in Westfir with gross annual receipts over \$5,000. Fee \$25.00\*
- (B) Businesses located in Westfir with gross annual receipts over \$5,000. Fee \$25.00\*
- (C) Any business located in, or doing business in, Westfir with gross annual receipts under \$5,000. No Fee
- (D) Any Contractor, sub-contractor or business performing work solely at the behest of, or because of contract with, the City of Westfir. No Fee

**BUSINESS LICENSE FEES ARE DUE BY JULY 31 OF EACH YEAR, FOR EACH MONTH THAT THE BUSINESS LICENSE FEE IS LATE, A \$10.00 PENALTY FEE WILL BE ADDED.**
